

### Annual Spring Conference Heading to Lake Placid! Do You Believe in Miracles?\*

NEISMA President Ben Ruggles announced at the recent Spring Conference and Trade Show in Falmouth, MA that the Board of Directors has decided to "take the plunge" into Lake Placid, NY as the host site of next year's event on April 22 - 25, 2018.

"With the success of our past few Spring Conferences,

and the fact that 2018 is a Winter Olympic year, we believe the timing is right to host the event at this historical location" said Ruggles. "We're giving folks plenty of notice to start planning now to join us in upstate New York next spring".



The Board's Conference Committee, chaired by Michelle Stenberg, is now putting together next year's program which will include appearances of past and present Winter Olympians. "We're seeking input and involvement from our members to put together a great program" Stenberg said at a recent meeting. "We'd like to know what people are interested in seeing at the Conference and what attractions they'd like to visit while in town. Some of us have never been to Lake Placid so we want to make the trip memorable and worth the investment."

The Committee is using the question "Do you believe in miracles?\*" to promote the event as, and Stenberg points out, "we never thought it would be possible for NEISMA to host our annual conference in such an iconic location. It truly is a miracle!"



As everyone knows, Lake Placid was the site of the "Miracle on Ice" when the US Men's Olympic Ice Hockey team won the Gold Medal in 1980 after defeating the heavily favored Soviet team in the semi-finals, then defeating Finland, 4-2 in the final game (see related story on page 23).



The NEISMA CUP, viewed as far superior to Lord Stanley's Cup by many participants, may have suffered its final indignity with the 2017 version of the "game" played at the Falmouth Ice Arena. Ironically, Cape Cod has hosted more NEISMA den), just out of the line-of-fire of the Smith & Wesson factory (Smead Arena), Falmouth Arenas both new and old, on the JFK surface in Barnstable, and the Cup "lived Free & Died" in Dover, NH (the Dover that lacks the white cliffs).

The 2017 Cup battle was slated for Tuesday, April 25 in a return trip to the 1 <sup>1</sup>/<sub>2</sub> surface "new" Falmouth Ice Arena. The pregame signups featured 23 All-Stars, 2 1/3 goalies, split very evenly between Vendors & Managers. The rosters were delivered to all registered combatants, the pre-game trash talking

was pervasive during the initial 2 days of the NEIS-MA Conference at the Sea Crest, the battle was tak-



ing shape! During the game day Trade Show, things began to turn dour for those hoping for a successful defense of the Cup by the managers. To the untrained eye, the trade show activity was benign. Those with knowledge of the rosters had suspicions, later confirmed by Sea Crest pouring records (after a Freedom of Information Act request by this author) that the managers team was partaking of the open bar exponentially more than the Vendors, who were strictly adhering to de facto Vendor Co-Captains Peter Manderino and Jeff Gray's prohibiting their team's game day nectar consumption!

Clearly, the Vendors were serious about recapturing their Cup after losing it in 2016 for the first time in many years.

I can think of nothing worse for a rink manager

than "double booking" their sheet of ice. Similarly, I can't believe the 2017 Conference Gods "double booked" the NEISMA Cup....I never saw it coming, the campaign was rather stealthy, but NEISMA "King Cornhole" David Korpiel managed to have his "tournament" at the Sea Crest concurrently with NEISMA CUP... Just as Peter Kozodoy had stated in his Employing Millennials presentation earlier in the day, the Managers team didn't show up to the rink because they hadn't bought in to the NEISMA Cup Culture, and the Cup did not have a ping pong table in the break room! The choice was clear, the result should have been aphoristic, I missed it. The chart illustrates it well:





### New Ownership Breathes Life into New York Rinks

Rory Fitzpatrick played in 287 NHL games and posted 10 goals and dished out 25 assists in his 12 year career. The 42 year old Fitzpatrick continues to be around rinks. Today, he partners with Tom Masachi, former RIT Hockey player and founder of Will Cup Management. They now operate three ice rinks in western and central New York.



They have bought rinks that needed a face lift. The former SIR Rink (renamed Paul Louis Arena, named after Tom's father) in downtown Rochester is over 60 years old. The also refurbished the Lysander Ice Arena twin rinks in central New York. The last investment was purchasing the old Thomas Creek Ice Arena and renaming it the Rochester Ice Center.

The Rochester Ice Center was purchased by a group of owners in June of 2016 headed by Masachi and Fitzpatrick. They have nine tenants who are proud to call the Rochester Ice Center home, They include Perinton Blades Youth Hockey, Rochester Monarchs, Rochester Jr. Monarchs, Rochester Ice Center Academy, Next Level Strength and Conditioning, Thomas Creek Figure Skating Club, and three high school hockey programs - McQuaid Jesuit, Victor and Fairport. Needless to say, the facility is very busy all year.

The management group came in and made improvements all around the facility. "The facility needed updated", Fitzpatrick said. "We made improvements to the snack bar, pro shop and bar." They also looked at reducing energy costs by installing a low E ceiling, "There were two reasons we decided to go with a low E ceiling. It is environmentally friendly and it will cut down energy," Fitzpatrick said. They also installed T-4 lighting to brighten the place up. Another major improvement was paving the parking lot. "Paving the parking lot gave the customer a better feeling about the place," Fitzpatrick concluded.



The Rochester Ice Center wants the customers to feel it is their rink. "The new ownership group really cares about the place. We want our customers to have a feel of 'ownership' and feel welcome," Fitzpatrick commented. The facility

has added new flooring and added two new locker rooms to accommodate all the teams that are using the facility. In addition to the aforementioned tenants, there are summer camps, public skating, men's leagues, Strong Hockey Camps and the Mirror Images Synchro Team that use the facility. "I think we have accomplished what we set out to do," Fitzpatrick said.

Not only have improvements been made to the Rochester Ice Center but also to the Paul Louis Arena. The facility has been updated and refurbished by adding a bar and new locker rooms. The most interesting aspect of

the new bar is the way it was remodeled. "They took the old wooden bleachers and used them to decorate the bar," according to Clint Campbell, GM of Paul Louis Arena. Campbell was hired away from the Greater Canandaigua Civic



Center to give Paul Louis Arena a fresh start.

Paul Louis is the practice facility for the Rochester Monarch, St. John Fisher College Club Hockey and McQuaid Jesuit High School varsity and 2 JV teams. Figure skating and public skating are also offered at the Paul Louis Arena. "We painted the place, added a new ceiling and new lights," Campbell added. "After 60 years, it needed a face lift. People still enjoy skating here because it is an original."

The Lysander Ice Arena in Baldwinsville, NY - just west of Syracuse - is the third Masachi/Fitzpatrick rink to have a facelift. It is home to Baldwinsville and Liverpool High School as well as the Lysander Lightning youth hockey program. It has added two new bars, rubber flooring and reworked and renovated the lobby area.

Hockey and ice skating seem to be doing well in western and central New York thanks to Tom Masachi and Rory Fitzpatrick's efforts and vision.

He is still on the road for plenty of miles but values his time with his family during his rare rest periods! I congratulated Chris on finding his piece of Massachusetts paradise....

THE STORIES – It takes a pretty good story to impress 150 years of experience, yet Chris offered up quite a few - the City who ordered an entirely new refrigeration plant to get their outdoor rink to freeze, but hadn't turned the glycol below 20 degrees because "someone" told them they couldn't (despite the unseasonably warm weather in the area). One quick freeze-point check and thermostat adjustment and that City had ice.....without unwrapping the new compressor package! Show up in Lake Placid for NEISMA 2018 and I'll share some more good ones!

THE CONANDRUM – Chris' clients ranged far and wide both geographically and economically. He received a Saturday night Service Call from a rink in a hardscrabble former mill town...the ice was melting, the machines were out on "HIGH HEAD PRESSURE". The mechanic arrived, checked the fan, the belt, the motor, electrical and the water supply....all appeared fine. The mechanic reset the machines, conscientiously stayed a few hours and all was well.....

Chris' company received the same exact Service Calls for the next two Saturday nights, with the results the same - machines out on HIGH HEAD PRESSURE, checked out fine and a reset restarted the system. By the third weekend, they were all scratching their heads.....

They opened the tower and looked inside, they spotted something that did not belong in there.

The mystery was solved...

### Zamboni Driver Saves Dad's Life

CANTON (CBS) – A quick-thinking Zamboni driver helped save a Dorchester, MA man who suffered a heart attack while playing hockey.

"I came out of the compressor room and I noticed a man down on the ice," said Eric Baker who drives the Zamboni at the Canton Sportsplex, in Canton, MA. Baker was working on Saturday as a group of fortysomethings, all friends who grew up together in Dorchester, had their yearly reunion and hockey game when 46-year-old Chris Gracia suffered cardiac arrest.

"His friends were around him and getting emotional and yelling," Baker said. Some of the friends were first responders and started CPR. Baker grabbed the rink's portable defibrillator.

"I got his shirt up, and got the pads on him and turned on the machine," Baker said. "Had to give him a shock. His whole body came literally up in the air."

Canton firefighters Jason Coleman and Brian Pendergast answered the emergency call. "They 100 percent saved this guy's life," Coleman said. "The key to surviving a heart attack is immediate, good CPR and they were all over it."

"I learned at the hospital he has two small children and the day before Father's Day, it's really nice," Pendergast said. "We don't always get good outcomes so this is really nice."

"It was emotional," Baker said. "It was hard but hopefully the fella's OK."

This is the second time Chris Gracia had a heart attack at a hockey rink and the second time CPR and a portable defibrillator saved him. He's still in the hospital and his brother says he is improving, but that his hockey playing days are over.



### Bringing a New Reality to Rockefeller Plaza

It was a November to remember and this night, New York City held up to its name as the city that never sleeps. As the world tuned in to watch the results of the US elections and find out who would become the 45<sup>th</sup> leader of the free world, I had the privilege to join the Jet Ice team at Rockefeller Plaza to assist in the installation of the on-ice logo. This was the third time that Jet Ice has played such an important role and their continued relationship with NBC News. It was history in the making for us as we embarked on a new reality of the future using on -ice virtual reality technology.



Rockefeller Plaza is an interesting venue. It is an outdoor skating facility that operates from October to April each year, attracting thousands of skaters each day. During each US election held every four years, Rockefeller Plaza is transformed into a visual elections info-graphic. A logo is carefully placed at centre ice with the complete US map outlining all the states. Over the past 12 years, Jet Ice has used a variety of logo materials at Rockefeller Plaza, some more challenging than others. As the results start to roll in, each state is then coloured with either red or blue to reflect which political party had won the state. This was the plan scheduled for this time around, but changed last minute due to use of on-ice virtual reality technology.

To accomplish this task a team of ice professionals were gathered to assist Dave Loverock from Jet Ice. Key assistants were George Arnaoutis and E.J. Gottwald. George has been in the ice business for over 25 years and is a Doug Moore student. With Doug's encouragement, George attended the ORFA Annual Professional Development Program held at the Guelph University and completed his CIT certification. EJ has over 15 years in the business as a practitioner, also CIT certified and a NEISMA board member. With their skills and expertise, both George and EJ value what ORFA has provided to the industry over the years and the level of professionalism. Two other valuable experts on hand included Joe Snecinski and Steven Farrell who often assist George on the US east coast. Both were scheduled for the entire project, but were sent home early as the use of virtual reality technology changed the original format.

The process was supposed to began at midnight on November 7<sup>th</sup> when the let lce crew were advised they could get things underway. We assembled at 11pm only to wait as NBC took over three hours to complete camera checks prior to airtime. As soon as this was complete we were cleared to get to work. The ice resurfacer tried to level the ice with no real success. The unit used by the ice resurfacer is not like any of the traditional manufacturers. Dave began his calculation measurements to centre the logo, but soon found out that he needed to make changes immediately. Some renovations had taken place since the last election, therefore new calculations needed to be done to ensure the logo was aligned to fit with the new measurements. Two different logo materials were used, a high porosity mesh and textile. The textile logo is the one at the top of the map with the NBC brand. It went down in minutes without any real effort blending perfectly into the ice. Because of the size of the map, high porosity mesh had to be used. Five panels measuring 14 feet wide were laid out (the complete USA print was 73.8' x 46'). Dave took the lead in ensuring that the seams were perfectly matched and then ample amounts of water was released on top by using a squeegee method over the material in an attempt to remove any air bubbles. It was obvious that the let lce team had done this before as they worked in harmony without having to be told what to do. Mesh logos are much more difficult to apply and some small creases and air bubbles occurred which bothered the ice crew, but those not trained in this field would never notice.

Stage two was to have the ice crew remove the Democracy Plaza logo replacing it with a US map outline.

Thomas Grosdoulies and his crew at the Newmarket shop had painstakingly hand-cut out all the artwork for this installation, only to have most of their work not be used. That was the original plan, but since NBC decided to shift to the virtual reality technology the hand placements were not going to be used this time. Virtual reality typically refers to computer technologies that use software to generate realistic images enabling the user to interact with a space and objects depicted using specialized display screens or projectors. In short, the viewer at home saw the state placement, while the on-ice logo never changed. A good example of virtual reality technology is used in football as television viewers see the yellow line to depict the required yardage.



Once the logos had been sealed in place, it was agreed that George, EJ, Steve and Joe would remain behind to build ice and Dave and I would take the morning shift after some sleep. For those who may have tuned in to watch NBC's syndicated morning show, *The Today Show*, you would have caught a glimpse of George finishing up. On election night, we had full access to the ice surface area. We chatted with NBC security who were full of questions about ice making and even had a chance encounter with Reverend Jesse Jackson as he made his way to the ice deck area for an interview.

As the election night continued, the Jet Ice team estimated schedule to remove the logo did also. The plan was for the ice crew to be on the ice by mid-night, however, it was the early hours of the morning before they were given permission to start the work. Removal involved merely digging down to the logos and hand ripping each panel out. This followed by ice repairs so the facility could then offer the traditional skating schedule by mid-day.

As I watched Dave go about his work over the time I was there, I reflected on how he has changed the business. All three of us, myself, George and EJ have been

mentored by Dave after Doug Moore left us much too early. There is no doubt that Doug built a strong foundation to ice making sciences and technologies, but Dave has taken these beginnings to a much higher level. I often speak with Dave about his contribution to the industry, but he is always content to shift the accolades back to Doug Moore being comfortable in his shadow. However, Dave, in my opinion, you have earned your place in the limelight as the industries best ice maker!

# "Miracle on Ice" Relived

It immediately became known as the Miracle on Ice. USA 4, USSR 3 in the 1980 Winter Olympic hockey semifinals. It was the result that shocked the world – free and otherwise.

Here was the vaunted Soviet juggernaut - Olympic gold medalists in 1964, 1968, 1972 and 1976 – out to prove the validity of their way of life. The last time the Winter Olympics were held in the United States - 1960 Squaw Valley, Calif. - hockey gold, ironically, went to the Americans. But that was considered ancient history. In addition to four straight Olympic titles, Russia had won the World Cup, the World Championships and had soundly defeated the same USA team, 10-3, at Madison Square Garden just two weeks before the Olympic tournament. The U.S. group was good enough for a medal, most felt, but was not in the league of the Soviets.

The team began the tournament with a come-back tie against Sweden as Bill Baker scored in the final 30 seconds of the contest to earn the deadlock. From there to the semi-finals, the U.S. steamrolled each opponent with a similar story line - stellar play from goalie Jim Craig and a burst of energy from all 20 players in the final period.

Norway, Romania, West Germany fell by the wayside and momentum and optimism was building. It reached a fever pitch when the home squad trounced gold medal contender Czechoslovakia, 7-3. Could the unthinkable really happen?

The night of Feb. 22, 1980 put it all into context. Twenty exuberant players and a single-minded coach hit the ice at 5:06 pm local time unaware that a nation, reeling from an unsettling situation in Afghanistan, a hostage crisis in Iran, a potential boycott of that summer's upcoming Summer Olympics in Moscow and a down-trending economy needed a pick-me-up. And did it get one.

The Russians, clearly overly impressed with their resume, skated in that manner. The U.S., playing with purpose before about 10,000 partisans, seemed to skate above the ice. Nevertheless, the USSR held the lead for much of the contest but could not shake the determined Yanks.

The USSR tallied first (Vladimir Krutov) which only seemed to add to their non-chalance. But later in the opening period, Buzz Schneider tied the count with a slap shot from the left wing. Unfazed, Russia went ahead on a goal by Sergei Makarov and were ready to take the 2-1 advantage into the first intermission. As time was expiring, the Americans fired the puck down ice while the Russians were headed to the locker room prematurely. But Mark Johnson, skating to the buzzer, walked in behind a sleeping Soviet defense that was moving in the opposite direction. Johnson grabbed the puck and fired it past the heretofore world's best goaltender Vladislav Tretiak with one second remaining.

2-2 after one period. This was noteworthy for the U.S on two fronts: they were deadlocked after one period and Tretiak was mysteriously benched in favor of Vladimir Myshkin.

The USSR's Alexandre Maltsev scored the only goal in the second period to take a 3-2 advantage. However, not many in the audience thought the matter would be this competitive after two periods.

At 8:39 of the final frame, pandemonium erupted when the Red, White and Blue knotted the score at 3all as Johnson tallied again. Now the visitors were embroiled in the game of their lives against the upstarts and it was clear that they could not shift gears.

The American system of playing in this tournament was actually patterned after the European method. At the time, North American hockey had devolved into a dull pattern of skating the puck to center ice, shooting it deep into the opponent's zone, chasing it and trying to get the opposition to turn it over to you for a scoring opportunity. However, USA coach Herb Brooks felt differently. He wanted to play a possession game emphasizing skating into open ice, precise passing and attacking. To this end, he recruited the fleetest feet in the country, mostly collegians and several minor league professionals. And, of course, he needed a clutch goalie.

When Mike Eruzione scored the famous fourth and winning goal with 10 minutes remaining in the game, a scene of delirium broke out. But still there were 10 minutes to play and, after all, these were the Soviets, who many felt could turn up the heat when needed. It was needed, but they could not turn it up.

With Craig's solid play in the net and the crowd spurring on the rest of the team, Russia had few good chances to tie, while the USA grew stronger and more confident.

As time wound down, sticks and gloves were tossed into the air and jubilation rang out across a nation.

A miracle had been created, one which has stood the test of time, and the likes of which we will never see again.


