The Zamboni: is 26 years old; was used at the Gallo Ice Arena; needs new batteries; is maintained by Farmer Brown; is in good working condition; contains an auto snow breaker, wash water system, board brush, lead acid batteries, headlights & horn; & has a 3-year old hydraulic motor.

Specifications for the Purchase of the Surplus ZAMBONI: Model Number 552

In accordance with the provisions of MGL Chapter 30b; Section 15, the Board of the Bourne Recreation Authority (BRA) have declared the used Zamboni: Model number 552; Serial number 7191 as surplus equipment to the needs of the BRA.

The Zamboni will be sold in its "as is" condition with no warranties being expressed or implied to the most responsive and responsible bidder offering the highest price. The purchaser must remove the Zamboni from the Gallo Arena within 2-weeks from the date executing the formal bill of sale.

INSPECTION OF THE ZAMBONI: there is NO mandatory requirement that potential bidders visit the Gallo Ice Arena to inspect the machine. To arrange for a visit to view the Zamboni, contact John Hickey, Gallo Ice Arena Manager, via 508-922-04282 Monday thru Friday - 8am to 4pm.

SALES AGREEMENT: within five(5) business days for the date of the Notice of Award from the BRA, the selected Purchaser and General Manager shall execute a Sales Agreement for the purchase of the Zamboni.

PAYMENT METHOD: the Zamboni will be sold to the selected purchaser who must remit to the BRA a Cashier's Check or Certified Money Order made payable to: Bourne Recreation Authority in the amount that has been agreed to for the purchase of the Zamboni. Said purchase is subject to the approval of both the BRA Administrative Coordinator and General Manager. The accepted Purchaser shall provide the funds to the BRA within ten(10) business days after executing the Sales Agreement that the BRA has accepted their purchase price.
